

**At Home [Get Organized] Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES INCLUDING THE DISTRICT OF COLUMBIA WHO ARE AT LEAST 18 YEARS OLD (OR THE AGE OF MAJORITY IN THEIR STATE OF RESIDENCE, IF OLDER) AT TIME OF ENTRY. VOID IN PUERTO RICO, GUAM, AMERICAN SAMOA, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

This sweepstakes is in no way sponsored, endorsed, administered by, or associated with Instagram, Inc.

1. Eligibility: The At Home [Get Organized] Sweepstakes (the “Sweepstakes”) is open only to individuals who are: legal residents of and physically residing in one of the fifty (50) United States or the District of Columbia, who are at least eighteen (18) years of age (or the age of majority in their jurisdiction of residence, if over 18) or older, and who are located in the United States or the District of Columbia, all at the time of entry. This Sweepstakes is void in Puerto Rico, Guam, American Samoa, all other United States territories, possessions, and protectorates, foreign based United States military installations and wherever restricted or prohibited by law. (Any person who attempts to participate in this Sweepstakes, regardless of whether they satisfy the above eligibility requirements and/or ultimately enter the Sweepstakes successfully, is referred to in these Official Rules as an “Entrant”). Employees, contractors, directors, officers, and agents of At Home Stores, LLC (“Sponsor”), its affiliates, subsidiaries, Robust Promotions LLC (the “Administrator”), and all of their respective partners, parent companies, divisions, subsidiaries, affiliates, trustees, advertising, promotion and public relations agencies, and their respective officers, directors, employees, agents, independent contractors, representatives and agencies (collectively, **the “Sweepstakes Entities”**) are not eligible to participate in the Sweepstakes and/or win a Prize (as defined below). Additionally, immediate family members of any such ineligible person and persons living in the same household as any such ineligible person (whether related or not) are not eligible to win. For the purposes of this Sweepstakes, “immediate family members” is defined as spouse, domestic partner, mother, father, grandmother, grandfather, children, siblings and their spouses, and “persons living in the same household” shall mean people who share the same residence at least three (3) months a year, whether legally related or not.

This Sweepstakes is subject to all applicable federal, state, and local laws and regulations and void where prohibited. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. 3. Sweepstakes Period: The Sweepstakes begins on 7/20/2021 at 12:00:01 am Central Time ("CT") and ends on 8/20/ 2021 at 11:59:59 am CT (the "Sweepstakes Period"). All entries must be received before the Sweepstakes Period end time/date to be valid. Entries received before and/or after the Sweepstakes Period will be void.

The winner selection for the Sweepstakes Entry Period (as outlined in Section 6 below) will take place approximately two (2) business days after the conclusion of the Sweepstakes Entry Period.

4. How to Enter the Sweepstakes: During the Sweepstakes Period eligible Entrants may enter the Sweepstakes in the following ways:

A. On Instagram: If the Entrant meets the eligibility requirements, during the Sweepstakes Period, Entrants must follow @AtHomeStores on Instagram and each week (i) screenshot the At Home Get Organized checklist posted to the @AtHomeStores Instagram Stories, (ii) complete that week's challenge, and (3) share a photo or video related to that week's challenge to their personal Instagram Stories tagging @AtHomeStores and including #Sweepstakes to receive one (1) entry into the Sweepstakes. Entrants who do not follow all of the instructions, provide all required information, and/or abide by these Official Rules or other instructions of Sponsor may be disqualified. *Entrant must have a public Instagram account to enter this Sweepstakes. Entrant's Instagram must be set to public during the Sweepstakes period, beginning at least on the date of entry, and for at least thirty (30) day thereafter.* If Entrant does not have an Instagram account, Entrant can create an Instagram account for free at Instagram.com or by downloading the application from the Apple App Store or Google Play Store and follow the instructions to set up an account. Instagram accounts are subject to Instagram's terms of use. Limit of one (1) entry per week into the Sweepstakes, per person regardless of the number of Instagram accounts they may have during the Sweepstakes Period using this method. During the Sweepstakes Period, Entrant may earn a maximum of five (5) entries total.

B. Online Form: If the Entrant meets the eligibility requirements and does not want to enter using the On Instagram method described above, during the Sweepstakes Period, Entrant may enter the Sweepstakes by completing the online form located at athome.com/social-sweeps/. Entrant must follow the on-screen instructions requested to complete all required fields, which may include, but is not limited to Entrant's name, email address, physical address, and telephone

number. Limit one (1) entry each week, for a maximum of five (5) total entries into the Sweepstakes per person, regardless of the number of Instagram accounts they may have during the Sweepstakes Period using this method.

Sweepstakes entries must comply with the Content requirements set forth herein, as well as any requirements or guidelines for posting to Instagram, to be valid. As used herein, “Content” refers to all content you submit in connection with the Sweepstakes (including, but not limited to, any pictures, images, descriptions, writings, explanations, hashtags, tag names, background, etc.). Sponsor reserves the right to disqualify any Entrant whose Content does not adhere to the submission requirements, as determined in Sponsor’s sole discretion. On Instagram Entries must be in English. By submitting Content for the Sweepstakes, you hereby warrant and represent that your Content conforms to the Content Requirements set forth below.

Automated entries are prohibited and any such use will cause the entry to be disqualified. Entrants may not enter with multiple email addresses/Instagram accounts nor may entrants use any other device or artifice to enter multiple times or as multiple entrants. If it is discovered that Entrant has entered or attempted to enter the Sweepstakes in excess of the stated limit by using multiple identities, Instagram accounts, or email addresses, or that Entrant submitted or attempted to submit more than the entry limit provided above, all of Entrant’s entries may be disqualified and ineligible, and any prize you Entrant may have been entitled to will not be awarded, as determined by Sponsor in its sole discretion. Sponsor’s decisions with respect to whether Content complies with these Official Rules are final and binding and may be made by Sponsor at any time. Content that do not meet the requirements set forth in these Official Rules may not be acknowledged, may be deleted, and may be automatically disqualified, in the sole discretion of the Sponsor.

Multiple participants are not permitted to share the same mobile phone, email account, or Instagram account. Data rates may apply. All rules, guidelines, and terms and conditions of Instagram, Inc. apply.

5. Content Requirements: Entrant represents and warrants that their Content is the original work of such Entrant, it has not been copied from others, it does not violate the rights of any other person or entity, and publication of the Content via various media including Web posting will not infringe on the rights of any third party. Entrant agrees to indemnify and hold harmless Released Parties (defined below) from any claims to the contrary. Any Entrant whose Content includes likenesses of third parties or contains elements not owned by the Entrant (such as, but not limited to, depictions of persons, buildings, trademarks or logos) must be able to provide legal releases for

such use including Sponsor's use of such Content, in a form satisfactory to Sponsor and/or Administrator, upon request, prior to award of prize.

By submitting Content, you agree that your Content is gratuitous and made without restriction, and will not place Sponsor under any obligation, that Sponsor is free to use or otherwise disclose the ideas and expressions contained in the Content on a non-confidential basis to anyone or otherwise use the ideas or expressions without any additional compensation to you. You acknowledge that, by acceptance of your Content, Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor, or developed by its employees, or obtained from sources other than you.

BY SUBMITTING AN ENTRY, ENTRANT ACKNOWLEDGES THAT THEIR ENTRY AND CONTENT MAY BE POSTED ON ANY MEDIA, NOW KNOWN OR HEREINAFTER CREATED, AS AUTHORIZED BY SPONSOR, IN SPONSOR'S SOLE DISCRETION. Submission of Content grants Sponsor and its agents an unlimited, worldwide, royalty free, perpetual, license and right to publish, use, display, reproduce, make derivative works from, and publicly perform the Content in any way, in any and all media, without limitation, and without consideration to the Entrant.

Sweepstakes Drawing/Odds: On or around two (2) business days following the completion of the Sweepstakes Period, Sponsor will randomly select one (1) winner from among all eligible entries received during the Sweepstakes Period. Sweepstakes and Contest Winner Notification: All potential winners will be notified via a comment on/response to their entry, direct message, email, or telephone call using the information provided in their entry (method to be selected by Sponsor in its sole discretion) in a commercially reasonable time after the drawing. Potential winners are subject to verification. Potential winners will have five (5) days to respond to the notice with the information requested in the notification or the prize may, Sponsor's sole discretion, be forfeited. If a potential winner is found not to be eligible or not in compliance with these Official Rules, if attempted notification or any prize is returned as undeliverable, if any required documents are not returned within the required time period, if a potential winner cannot be verified, or if a potential winner is otherwise unable or unwilling to accept and claim the prize as stated, then the potential winner may be disqualified and the prize may be forfeited in Sponsor's sole discretion. Inclusion in such drawing shall be each Entrant's sole and exclusive remedy under such circumstances. The Sweepstakes Entities are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify the potential winner.

8. Prizes: One (1) verified Sweepstakes winner will receive one \$500 At Home gift card. Total ARV of all Sweepstakes Prizes: **\$500.**

Prizes are non-transferable and no cash equivalent or substitution of prize is offered, except at the sole discretion of the Sponsor. If a prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute prize with another prize of equal or greater value. Prize winners will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prizes they receive, regardless of whether it, in whole or in part, is used. Please allow 4-6 weeks for electronic delivery of prize after confirmation. Gift cards are subject to the terms, conditions, and restrictions as set by Sponsor. Sponsor will not replace any lost or stolen gift cards.

9. Release: As a condition of entering, Entrant agrees (and agree to confirm in writing): (a) to release Sponsor, Administrator, each of their affiliates, subsidiaries, retailers, and agents, and each of their officers, directors, employees and agents ("Released Parties"), from any and all liability, loss or damage incurred with respect to the awarding, receipt, possession, and/or use or misuse of

any prize including any item redeemed therewith; (b) under no circumstances will any Entrant be permitted to obtain awards for, and Entrant hereby knowingly and expressly waives all rights to claim, punitive, incidental, consequential, or any other damages, other than for actual out-of-pocket expenses and/or any rights to have damages multiplied or otherwise increased; (c) all causes of action arising out of or connected with this Sweepstakes, or any prize awarded, shall be resolved individually, without resort to any form of class action; and (d) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred (if any), excluding attorneys' fees and court costs.

Should Sponsor fail to request the said assignment as stated, that shall not be deemed a waiver of Sponsor's rights and Sponsor may at a later time request the assignment.

11. Publicity: Except where prohibited by law, each winner grants (and agrees to confirm this grant in writing, if requested) permission for Sponsor and those acting under its authority to use their name, photograph, and/or likeness, for advertising and/or publicity purposes in any and all media now known or hereinafter invented without territorial or time limitations and without compensation.

12. General Conditions and Limits of Liability: Sponsor is not responsible for lost, late, misdirected, undelivered, incorrect, or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries. Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason or if any fraud, bugs, virus, technical failures, or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined

by Sponsor in its sole discretion. In the event of cancellation, Sponsor will award the prizes from among all eligible, non-suspect entries received prior to cancellation in a manner deemed fair and equitable. Sponsor is not responsible for computer system, phone line, hardware, software or program malfunctions, or other errors, failures or delays in computer transmissions, the website, or network connections that are human or technical in nature. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process, any website or application used in connection with the Sweepstakes, or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other sweepstakes or in an unsportsmanlike or disruptive manner. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

13. Binding Arbitration: Any controversy or claim arising out of or relating to this Sweepstakes shall be settled by binding arbitration in Plano, Texas or if such location is not permitted, then a location determined by the arbitrator as set forth herein (provided that such location is reasonably convenient for claimant), or at such other location as may be mutually agreed upon by the parties, in accordance with the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS ("JAMS Rules and Procedures") then prevailing, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having

jurisdiction thereof. The arbitrator shall be selected pursuant to the JAMS Rules and Procedures. The arbitrator shall apply Texas law consistent with the Federal Arbitration Act and applicable statutes of limitations, and shall honor claims of privilege recognized at law. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS SWEEPSTAKES IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.

14. Governing Law & Jurisdiction: This Sweepstakes and its Official Rules are governed by US law and are subject to all applicable federal, state and local laws and regulations. All issues and questions concerning the construction, validity, interpretation and enforceability of the Sweepstakes Official Rules, or the rights and obligations of entrants and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas, U.S.A., without giving effect to the conflict of laws rules thereof, and any matters or proceedings which are not subject to arbitration as set forth in Section 13 of these Official Rules and/or for entering any judgment on an arbitration award, shall take place in the State of Texas, in the City of Plano or nearest of a competent court having jurisdiction over such matter.

15. Entrant's Personal Information: Please see the privacy policy located at <https://www.athome.com/privacy-policy.html> for details of Sponsor's policy regarding the use of personal information collected in connection with this Sweepstakes. If you are selected as a winner, your information may also be included in a publicly-available winner's list.

16. **Miscellaneous:** The invalidity or unenforceability of any provision of these Official Rules or the Affidavit will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules or the Affidavit is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsors' failure to enforce any term of these Official Rules or any other guidelines, instructions, policies, or term will not constitute a waiver of that provision. Entrant agrees to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
